1. OBJECTIVES

4 REVIEW OF FINANCIAL STATEMENT AND EXPLANATION OF MAJOR FINANCIAL TRANSACTIONS

4.1 Surplus

The Society recorded a surplus of **S\$438,714** in the year **2018**.

We wish to thank our Committee members, members of the Society and devotees for their kind assistance and boundless support rendered to the Society.

4.2 Reserve Position and Policy

The Sagaramudra Buddhist Society's reserve position (excluding non-current assets and deferred capital donation) for the financial year 31 December 2018 is as follows:

Notes:

A Reserves that we have set aside provide financial stability and the means for the development of our principal activity. From the accumulated general fund as at 31 December 2018, the Society set aside S\$1.53M as



Reserves after provided S\$400K for extension, A & A and cyclical maintenance works at 5 Lorong 29 Geylang, and S\$400K as Welfare Fund for Reverends. In the subsequent years, the Society plans to continue to build up the Reserves after the existing building at 574, Changi Road is sold. We intend to maintain unrestricted funds at a level of S\$3.2M to maintain the Society as a going concern. This is approximately five years of expenditure, including depreciation.

B The Building Fund is for the extension, A & A and cyclical maintenance works of building at 5 Lorong 29 Geylang. The estimated cost is S\$6M which is derived as follows:

Extension of building = additional area 20,000 sq ft x estimated construction cost \$275 per sq ft = S\$5.5M

A & A and cyclical maintenance works = S\$500K

C A total amount of S\$400K is set aside for Welfare Fund (Designated Fund), an increase of S\$100K over FY17 sum provided. The Welfare Fund includes expenses such as surgical and hospitalization etc to support the existing 13 Venerables. The Society plans to build up this fund progressively.

The Society will be reviewing its Reserve Policy annually.

4.3 Major Financial Transactions

4.3.1 As at end of the financial year, the Society spent an accumulated amount of S\$1.426m for acquisition and reconstruction of the building at 12 Cedar Avenue. Part of the total cost is financed by a donation of S\$800K. The reconstruction works were completed in 2018. The property has been capitalized and started to depreciate in 2018.

4.3.2 The Society has yet to dispose of its property at 574 Changi Road, given the soft market conditions, and the Society will sell this property in due course.



5. EXPLANATION OF THE PURPOSES FOR WHICH THE SOCIETY'S ASSETS ARE HELD

5.1 Land and Building at 5 Lorong 29 Geylang Singapore 388060

Property purchased in 1999 by the Society for the purpose of setting up a Buddhist Institution for the propagation of the Buddha's teachings.

5.2 Land and Building at 574 Changi Road Singapore 419944

Property purchased in 2002 by the Society as dormitory for Buddhist nuns providing Buddhist teachings, administrative and religious services at the Society.

5.3 Land and Building at 12 Cedar Avenue Singapore 349698

Property purchased in 2016 by the Society as replacement dormitory for Buddhist nuns of the Society.

5.4 Passenger Van (Plate No. : PA6730S)

Van purchased in 2007 for use by the Society.

5.5 Passenger Car (Plate No. : SLD9865Z)

Car purchased in 2016 for use by the Society. The car was sold for a consideration of \$105,000 subsequent to the financial reporting period.

6 FUTURE PLANS AND COMMITMENTS

As an on-going concern, the Society will continue to propagate the teachings of Buddha by conducting classes, talks, meditation lessons, observing and performing Buddhist rituals and ceremonies.
